2) It will be mandatory for your school to impart education in Punjabi upto Xth class & C.B.S.E. will definitely make arrangement to hold examination of Punjabi in such schools & it is also stated here that non-compliance with the same will amount to the immediate annulment of the No Objection Certificate.

3) After securing affiliation with the C.B.S.E., the Management of the School will be committed to pay its teaching as well as non-teaching staff, the salaries and other allowances etc. at parity with the Government employees. Non-compliance with the same will amount to the immediate annulment of the No Objection Certificate.



4) You and your Management will ensure that whenever an access to any information is desired by the District Education Officer of your District or any of the senior functionaries of the Education Department, then same will be made available to him together with the needed assistance.

5) Your Management will make sure to produce Fire Safety Certificate for the School Building to the Government after obtaining it from District Fire Officer, Patiala within a period of one month, in case this certificate is not produced within a period of one month from issuance of this No Objection Certificate, then this No Objection Certificate will be cancelled.
