RULES REGULATIONS AND THE ARTICLES OF CONSTITUTION OF SCHARDAM SINGH MEMORIAL EDUCATIONAL AND WELFARE SUCIETY

#### Article - 1. Governing Sodya

The Governing Body of the society shall comprise and elect the following as per the process prescribed herein.

- 1. The President : Permanent Post.
- Vice President will be nominate by the President. 2.
- 3. Gen. Secy. will be nominate by the President.
- Asst.Secy. will be nominate by the President. 4.
- Cashier will also be nominate by the President.
- 6. Advisor will also be nominate by the President.

### Article - 2.

That in compliance with the instructions of the Education Department, Punjeb Govt. a committee of 7 members on the Delhi Pattern or on the other pattern decided by the Managing committee of this society shall be constituted and set-up.

The society have to & create maintain and teach levality, love and respect for the country, constitution, flags, parents and teachers of India.

The society will open and official other schools colleges. and technical institutions to it.

#### article - 3.

The funds of the committee shall be composed of the following :

- Subscription of members plus penalities. 1.
- 2. The income from the land allotted or to be allotted or to acquired by the schools or any other property accuired by the society both moveable and immovable.
- Donations from the Public or loan borrowed by the society, any 3. financial help given by the State or the Central Govts, or the local bodies govt. All the funds of the committee so collected shall be deposited in any of the scheduled bank.

- 4. All accounts of the society shall be operated by the President.
- S. The income and property of the society solely when so ever drive shall be supplied for the promotion off the objects of the committee as set forth in the memorandum of association and no portion thereof shall be paid or transfered directly or indirectly way of dividends, bonds or otherwise by way of profit to any person who so ever may be.

provided that nothing herein contained shall prevent the paymen in good faith or reasonable and proper resumption, remuneration any of any its officer or servents or any other person in return for any service actually rendered to the committee.

- 6. No member shall be appointed to any salaried officer of the society or to any office of the committee etc.
- The winding up of the committee will be covered as per the provisions of societies Registration Act, 1360.

#### Article - 4.

The affairs of the society shall be managed by the managing committee so appointed by the President from time to time. The control to the school/s/colleges atc. and all proporties movable or immovable belonging to it shall west in the President The President of the committee will nominate office bearers and other official staff such as Manager, teacher, Peon , clerk etc. he can also appoint secretary, accountant and cashier alongwith the other office bearers of the society.

#### Article -5

### Powers of the President.

- 1. The President will exercise the powers of the committee in anticipation of its approval under emergent situation. He is also delegate his powers to any member of his choice.
- Discretionary powers regarding the decision of the emergency also rest with the President.
