RULES REGULATIONS AND THE ARTICLES OF CONSTITUTION OF S.HARDAM SINGH MEMORIAL EDUCATIONAL AND WELFARE SOCIETY

Article - 1. Governing Body:

The Governing Body of the society shall comprise and elect the following as per the process prescribed herein.

1. The President : Permanent Post.
2. Vice President will be nominate by the President.
3. Gen.Secy. will be nominate by the President.
4. Asst.Secy. will be nominate by the President.
5. Cashier will also be nominate by the President.
6. Advisor will also be nominate by the President.

Article - 2.

That in compliance with the instructions of the Education Department, Punjab Govt. a committee of 7 members on the Delhi Pattern or on the other pattern decided by the Managing committee of this society shall be constituted and set-up.

The society have to & create maintain and teach loyalty, love and respect for the country, constitution, flags, parents and teachers of India.

The society will open and official other schools colleges, and technical institutions to it.

article - 3.

The funds of the committee shall be composed of the following :

1. Subscription of members plus penalties.
2. The income from the land allotted or to be allotted or to acquired by the schools or any other property acquired by the society both moveable and immovable.
3. Donations from the Public or loan borrowed by the society, any financial help given by the State or the Central Govts. or the local bodies govt. All the funds of the committee so collected shall be deposited in any of the scheduled bank.

4. All accounts of the society shall be operated by the President.
5. The income and property of the society solely when so ever drawn shall be supplied for the promotion of the objects of the committee as set forth in the memorandum of association and no portion thereof shall be paid or transferred directly or indirectly by way of dividends, bonds or otherwise by way of profit to any person who so ever may be.
Provided that nothing herein contained shall prevent the payment in good faith or reasonable and proper remuneration, any of any its officer or servants or any other person in return for any service actually rendered to the committee.
6. No member shall be appointed to any salaried office of the society or to any office of the committee etc.
7. The winding up of the committee will be covered as per the provisions of societies Registration Act, 1860.

Article - 4.

The affairs of the society shall be managed by the managing committee so appointed by the President from time to time. The control to the school/s/colleges etc. and all properties movable or immovable belonging to it shall vest in the President. The President of the committee will nominate office bearers and other official staff such as Manager, teacher, Peon, clerk etc. he can also appoint secretary, accountant and cashier alongwith the other office bearers of the society.

Article -5

Powers of the President.

1. The President will exercise the powers of the committee in anticipation of its approval under emergent situation. He is also delegate his powers to any member of his choice.
2. Discretionary powers regarding the decision of the emergency also rest with the President.

Article - 9. Power to make Bye-laws.

Executive committee may from time to time make alter or repeal any of the bye-laws given in this memorandum of Association as may be necessary or convenient for the proper conduct and welfare of the society.

The society shall keep a proper register/record to be kept in the office of the society alongwith the rules and regulations of the society under the supervision of President.

The committee shall keep true accounts of the society to be kept of all money received and expended by the society and the matter in respect of which such receipts and expenditure take place, the assets credits and the liabilities of the societies shall be maintained. In every case decision of the President will be final and will be obeyed by every person relating to the society. So all the members of the committee gave their free consent and admits the rules framed hereunder and promise to abide by the rules mentioned in the Memorandum of Association.
